Each year, we graduate young men who, for their years at St. John's Jesuit, have benefited from *Cura Personalis* and are prepared to go out and make a difference as *Men for Others*. They have been given opportunities to learn to think for themselves, provide leadership, work as part of a team, and advocate for the underdog. Some gifts have enhanced student/teacher resources, such as 21st Century classrooms and tech labs, while others have enhanced the way we welcome others to our school, specifically outside signage and our Eidi Admissions Center. Several gifts have been put in place that will be used to advance future student opportunities.

I am proud to report to you the 2019 endeavors that strive to meet the needs of every kind of student:

- Expanding the Office of College Counseling to specifically include career counseling
- Launching an esports team that will compete in state-selected video games against other schools
- Increasing student opportunities in business and entrepreneurship through a series of clubs developed over the next three years, including portfolio investment, data analytics, Bloomberg Terminals, Shark Tank (presentation of business plans), and a student-run campus business

All the above happens because of *you*. More importantly, it begins with accessibility and affordability. With your help, we continue to make great efforts to enable each student to develop his own path for the Greater Glory of God. As we pay witness to the fantastic work of our alumni within church, community, leadership, and careers, we are humbled and proud of the legacy that is St. John's Jesuit.

# **OPEN DOORS THROUGH PLANNED GIVING**

Generations of graduates care deeply for the future of St. John's Jesuit and want to ensure strategic growth and development. Through planned giving, our mission of forming *Men for Others* in northwest Ohio is secured, no matter what the economic or political landscape. Those who include SJJ in their estate planning are indeed a group of like-minded individuals who hope to make the school strong and resilient for years to come. They strongly believe that what is being accomplished at St. John's Jesuit needs to continue going forward.

As our alumni population continues to grow, it is true that it is aging. In this regard, many of the earlier graduates are looking to support the school in ways they were unable to before. Those men, along with parents, grandparents, and friends of SJJ, make up a considerable group of people who are in a position to support St. John's Jesuit through planned giving techniques.

Until now, we have recognized those who support SJJ through planned giving as members of the Legacy Circle. Going forward, the Legacy Circle is now known as the St. John Berchmans Legacy Society to more closely align the generosity of these gifts to their long-term commitment to the ministry of a Catholic Jesuit education.

Planned giving can be achieved in several ways, including charitable bequests, annuities, stocks, life insurance policies, retirement plan assets, charitable trusts, and Required Minimum Distributions (RMDs). We advise prospective donors first consult with an attorney, accountant, or wealth planning professional to explore all the options. The Advancement Office will work diligently to make the process simple and transparent by initiating the gifting agreement with a simple form, known as a nonbinding "Letter of Intent".

Colonel Mark Swentkofske '84 decided to support SJJ by making St. John's Jesuit the beneficiary of a life insurance policy.



"The value and beauty of the Jesuit high school experience and education is not just your own experience, but how you can then provide the experience or make the experience better for others behind you. "I was so prepared for college after my SJJ high school experience. I am forever grateful for all of the things I learned and the encouragement I received, and know I will probably never be able to fully repay SJJ.

Fifteen years ago, I realized the original bad gym floor we played on had never been replaced; we still couldn't play big games at SJJ because we lacked adequate seating and our sound system was horrible. I was blessed at the time to have the money from a recent business sale to upgrade the gym, so I called a fellow alum to see if he wanted to team up and tackle this project. The result was a new floor, which is so rewarding to see when we play St. Francis at home!!

The same concept applied to the football field; for this improvement, I teamed up with others to lead the campaign. For SJJ to continue to compete in the Toledo market and stay relevant, we needed a new stadium. It is great to see us host so many events that used to go to other venues.

Last year, I was driving down Airport Highway and passed our old school sign, which had been there since SJJ opened. I also started noticing that many other schools had updated digital signs that put ours to shame. I figured it was time to fix this problem and gladly funded the cost to upgrade our signage. I am amazed how this change improved our campus.

# **OPEN DOORS THROUGH PARENT GIVING**

Parents choose to invest in their son's education at St. John's Jesuit High School & Academy for many reasons. Some are alums and want their son to receive the same education and foundation as they did. Some want a school for a strong faith-based education. The reasons are endless.

We work purposefully with families to ensure they can afford this education. What many might not know is that the cost of tuition does not fully cover the expense to educate their son, commonly known as a "gap." This difference is covered in many ways through fundraising, including by parents giving beyond tuition. For those who are capable, it is a way to pay it forward, but also an investment in future programming, capital improvements, and other initiatives that will benefit their son and future Titans.

"Andrew Carnegie said that it's more difficult to give money away intelligently than to earn it in the first place, and I've come to believe him. I happen to sit on the board of a small charitable foundation, and we spend much more time deliberating our charitable selections than on investing or other administrative matters. I've learned it's important and rare to find a cause which could really use the money, is sure to use it responsibly, and offers a means of leveraging the gift, so that the gift promises a larger future payoff than its monetary value would suggest.

In my own family's much more modest giving, we deliberate with the same three factors. As both a graduate and parent of a current senior, I've been gratified to discover SJJ fits these descriptions perfectly. While SJJ's future is certainly financially sound, it's still dependent on enrollment and financial gifts, and every size gift matters. Since my son started attending the Academy, I've had seven years to learn of the all-around excellence St. John's offers, and I feel confident that our financial gifts (as well as tuition) are very well used indeed. Finally, there's the simple fact of touching the future by helping to support a school. Students at SJJ become leaders and Men for Others, and they remain loyal Titans. Our giving may help fund a current student, who will most likely continue paying it forward (to St. John's and elsewhere in the world) long after we're gone.

My wife and I have another personal reason we support SJJ: I spent the bulk of my working life teaching at a Catholic high school, so we know of the financial and temporal sacrifices that everyone on the faculty, staff, and administration makes to be at St. John's. It's inspiring (and unmatched). And it's worth supporting, not least because it's a way to say thank you to everyone."

"We decided to support SJJ with a monetary gift because we are aware of how expensive a quality education is and how few people can afford to cover the whole cost of it from their own income.

We appreciate and applaud the two new programs SJJ was looking to fund in entrepreneurship and computer science. Both of these areas are underrepresented or largely absent in high school curriculums in the U.S., and we hoped our son and others will directly benefit from them, particularly because a stronger computer science program in high school can help students who aren't headed for college to find a job straight out of high school. We were also impressed with the obvious amount of work and thought that Mr. Savona and others at the school had put into these new programs.

Finally, we are grateful for the culture we've observed among teachers and administrators at SJJ and know firsthand how much our son has benefited from it. Specifically, SJJ balances an emphasis on academic rigor with other very important values. The middle way is often hard to find, but it is clearly a lodestar for SJJ."



"Paul was, first and foremost, a gift to all who knew him and to all who came across his path in this world. He was the brightest spot in any room he entered because he had an undeniable gift of making others feel at ease, accepted, and appreciated. He exemplified what it means to be a Man for Others.


Just five years into our marriage Paul took on brain cancer with determination and a sense that this battle was just something he had to endure. His life example was his mission. He was so inspirational to everyone who watched him walk through this struggle and even more of a support to those who were diagnosed. In the middle of all of it, Paul kept the faith. His net was cast wide, and God provided so many blessings that we will be counting them for years to come.



His roots at St. Pat's and SJJ were undeniable and an integral part of his character. He adored being a kid at heart and surrounded himself with his nieces and nephews. With no children of our own, these kids became our passion. A scholarship was started because of Paul's inspiration to his family and friends. We have David DePrisco '81 (and a St. Pat's grad) to thank for starting the conversation and for starting the fund. Family members met to come up with the criteria. Those meeting were wonderful and a great way to share stories. From these discussions, we decided that recipients should aspire to possess the qualities that Paul lived out:



- 2. Trust in God. Faith, hope, and love were reflected in how Paul lived.
- 3. A demonstration that life is good. Paul had a positive and proactive approach to all situations.
- 4. A fist-clenching determination to succeed in the face of adversity.
- 5. A sense of humor and upbeat spirit. Go Irish! Go Titans! Go Rockets!
- 6. Concern for others' welfare. Paul often would use the phrase, "What's your story?"
- 7. An advocate for fairness.

# OPEN DOORS THROUGH ACADEMIC INITIATIVES

Attracting and retaining academically talented students requires constantly evaluating curriculum and assessing the way the needs of students are met as they graduate into an ever-changing job market. Financial support for forward-thinking academic initiatives is vital and requires a leap of faith. In 2019, the first phase of the Business and Entrepreneurship Program (BEP) was launched with the introduction of the Entrepreneurs and Stocks Trading clubs. The vision for BEP is a series of offerings that develops a deeper understanding of financial markets; teaches money management, collaboration, and strategic thinking; provides hands-on learning opportunities; and builds confidence in students by giving opportunities to develop an idea supported by a business plan. Because of the generosity of donors who desired to direct their gift to curriculum development, the BEP will soon move on to the second of three phases, and we anticipate it will be fully integrated into the curriculum for the 2021–2022 school year.

#### **Business and Entrepreneurship Program Highlights**

- Purchase of software to enhance learning of the financial market (certification is available with modules on economics, fixed income, equities, and currencies)
- · Creation of an Investment Club
- Creation of a student-run small business division of St. John's Jesuit, such as a café or bookstore
- Ideation whereby students develop a concept and, in "Shark Tank" style, develop a business plan and propose it to an investment team
- Critical thinking skills formed for data, analytics, and dynamic storytelling.

# **OPEN DOORS THROUGH THE** YOUNG ALUMNI COUNCIL

A new alumni initiative, known as the Young Alumni Council (YAC), provides graduates who are younger than 40 with the opportunity to come together to share their great passion for SJJ and its mission to develop *Men for Others* in Northwest Ohio. YAC members are asked to pledge a gift at the President's Council level, which is \$1,500 per year, for four years. Doug Pearson, "Coach P." has spearheaded the organizing and recruiting efforts for YAC and has been instrumental in giving the group a place and a purpose: "This group has many talents; they are very enthusiastic about their line of work, and they all share a love for SJJ. They want to be *Men for Others* in their giving—both financially and with their time."


