





# RAISING ST. JOHN'S JESUIT TO NEW HEIGHTS



In 2020, two generous families surpassed the one million dollar gift mark at SJJ, a rare milestone worth celebrating. When SJJ needed them, they were there. Their support, and the support of many others, has bridged possibility to the reality that SJJ is the premier academic, spiritual, and athletic school for boys in northwest Ohio.

Many thanks to our one-million-dollar donors. We could thank you a million times, but it would never be enough.

#### JUDGE RICHARD B. AND JANE MCQUADE

Anyone who has ventured through the halls of St. John's Jesuit has seen the name McQuade a few times, and especially over the doors of the theater inside the Carty Fox Commons. The Honorable Judge Richard B. McQuade and his wife, Jane, generous supporters of SJJ in so many ways over the last few decades, have recently surpassed the \$1 million donation mark. Their gift of the theater years ago was because, as Judge said, "Fr. Don Vettese talked me into it." Always joking, he quickly praised Fr. Vettese, remarked on his "sales" skills, and was happy about the way the theater fit into the heart of the school.


The McQuades generally give to three major areas. The first is to a scholarship named for Timothy McQuade, the Judge's brother, who was killed in 1956; the scholarship goes to underprivileged young men who would never be able to attend SJJ without financial assistance. The second is to capital projects such as the McQuade Theater. The third is to projects that involve entrepreneurship and innovation. "This kind of thinking is 'Jesuit'; reaching out to find new ways to educate is exactly how Jesuits operate," McQuade said.

Although he is not a graduate of SJJ (the school had not yet been revived when he was in high school), his father is a graduate of the "old" St. John's, as are several uncles. Currently, he has two grandsons at the school, as well as four other grandsons at different Jesuit schools. "I guess their parents understood how firmly we believe in a Jesuit

education," the Judge laughed. Judge speaks so highly of his father, who practiced his Jesuit values daily. "My dad was skilled in speaking, writing, and critical thinking. Early in my career as a lawyer, I practiced with my dad and saw these skills in action daily. He credited St. John's for them."

Later, Judge McQuade welcomed his opportunity to be on the Board of Trustees at SJJ. "I hoped that being on the Board would help me make sure that the skills Dad learned through his Jesuit education would carry on in other students," he said.

#### MIKE THAMAN AND LISA GATHARD

"We believe in Jesuit education," Mike Thaman, former Board member (2015-2020) and current SJJ parent, answered effortlessly, as a simple explanation to his family's reason for donating \$1 million to St. John's Jesuit over the past 17 years. "My wife, Lisa Gathard, and I feel that the concepts of *Men for Others* and the Grad at Grad are excellent values that we wanted our sons to have in their lives."

Mike is, himself, Jesuit-educated, having attended St. Ignatius High School in Cleveland. His father attended St. Xavier High School in Cincinnati. The Jesuit roots in his family run deep, and he and his wife were happy to have their sons continue the tradition at SJJ. "Our four Thaman boys all attended the Academy, as well as the high sch

attended the Academy, as well as the high school. Our two boys from Guatemala came to live with us in eighth and ninth grade, and they began at the school right away."

In all, the Thaman family boys include Hanssel Martinez-Guerra, Harry '13, Jessi Martinez-Guerra '15, Franklin Martinez-Guerra '17, Louie '18, Joey '19, and Paul '22. Two girls are part of the family, as well—Beatrice (St. Ursula Academy '15) and Rosi (Notre Dame Academy '23).

Mike and Lisa started giving to SJJ in 2004. In addition to consistently supporting important fundraisers such as Dinner Under the Dome, their focus has been on areas such as faculty professional development initiatives, the A+Learning Center, student performance initiatives, Adopta-Student, and the 20/20 Jesuit Scholarship program.

While they are supportive of the entire school, their gifts have most often centered on the educational aspects of the institution and on recognizing faculty for their efforts. Specifically, the Thamans underlined the following four areas on which to focus for maximum impact: improving homework completion in the Academy, a key factor for academic success; identifying struggling or atrisk students in the high school and providing intensive support services and supervision to get them on a path to academic success; increasing the orientation and skills training for incoming freshmen throughout their first year in the high school; and providing an additional pathway to calculus for students in the high school.

"We believe in investing in people," Mike said. "We like to give gifts to areas that will have a big impact on the students and the faculty. While we don't seek attention, we believe it's important to encourage others to step up and give to significant causes."



### TITAN MAGIS TUITION PROGRAM ASSISTS FAMILIES OVER



The COVID-19 worldwide pandemic abruptly affected the financial well-being of many families across the country. The Titan community has been no exception, which prompted the launch of the Titan Magis Project to offer relief to families in need of unexpected tuition assistance. The immediate generosity of lead supporters Marc '79 and Joy Lautenbach, Marilyn Dittrich, and Matt '78 and Adria Mossing provided a strong foundation for this initiative, which helped 28 students return to St. John's Jesuit for the 2020–2021 school year. Support for Titan Magis Project continues to be critical to sustaining enrollment, as even more families have been impacted in the past year. What started out as working overtime drastically changed when I was hospitalized in step-down ICU with COVID for 12 days. I left the hospital with a walker and home oxygen and was off work for nearly two months. My husband did his best working from home, attempting to hold down the fort with the kids, homework, and his own job. The financial impact of COVID was extreme because of the loss of income for weeks, along with the hospital bills that accumulated.


#### THE HARRIS FAMILY/BRYCE HARRIS '24

We had no income from our businesses until we were able to reopen. My husband was closed until the end of May. I was able to partially open in June, but because my business runs the length of a school year, we didn't fully open until the end of August.

Because of this situation, I was very worried about keeping up with our bills. I contacted St. John's to seek help during these tough times. The school has been so good for our son, so I could not imagine him going anywhere else, and it would've broken his heart to have to leave. St. John's jumped right in and helped us in our time of need by decreasing our tuition amount, and this blessing could not have come at a better time. Because of the administration's generosity, our son was able to stay at this amazing school.

### Planned Giving is Support that Spans Beyond a Lifetime

Generations of graduates care deeply for the future of St. John's Jesuit and want to ensure strategic growth and development for the school for decades to come. Through planned giving, our mission of forming *Men for Others* in northwest Ohio is secured, no matter the economic or political landscape. Those who include SJJ in their estate planning are indeed a group of like-minded individuals who hope to make the school strong and resilient for years to come. Known as the St. John Berchmans Legacy Society, these supporters strongly believe that what is being accomplished at St. John's Jesuit needs to continue going forward.

As our alumni population continues to grow, it is true that it is aging. In this regard, many of the earlier graduates are looking to support the school in ways they were unable to before. Those men, along

with parents, grandparents, and friends of SJJ, make up a considerable group of people who can support St. John's Jesuit through planned giving techniques.

Planned giving can be achieved in several ways, including charitable bequests, annuities, stocks, life insurance policies, retirement plan assets, charitable trusts, and Required Minimum Distributions (RMDs). We advise prospective donors first consult with an attorney, accountant, or wealth planning professional to explore all the options. The Advancement Office will work diligently to make the process simple and transparent by initiating the gifting agreement with a simple form, known as a nonbinding "Letter of Intent."

# GENEROUS DONATION FROM A CATHOLIC EDUCATION SUPPORTER



A dedicated father of nine, Thomas J. Mitchell of Maumee passed away in December. In his estate was a more-than-generous gift to St. John's Jesuit, a school he never attended but thoroughly admired.

Tom was a native Minnesotan who attended St. Mary's College for a year and a half. His time at a Catholic college made a lasting impression on him. Financial issues forced him to leave the school too soon, but he completed his degree at the University of Minnesota while working full time, getting married, and starting his family. But he never forgot his time at St. Mary's.

A few years later, Tom was asked to join a company in Ohio, Spartan Chemical, so he packed up his family and moved to Maumee. He and his wife raised their nine children there, becoming involved at St. Patrick of Heatherdowns parish, in local baseball organizations, and in many other community groups.

Tom's career advanced and so did his commitment to his church and neighborhood. He was beloved by the many people who worked with him—both at his company and in his many volunteer positions—but even more loved by his children,

siblings, 17 grandchildren, and six great-grandchildren. Two of his grandsons attended SJJ, and Tom was thoroughly impressed by the Jesuits and their educational philosophies.

Tom's love of Catholic education—fostered at St. Mary's—caused him to generously leave a gift to not only SJJ,

but to the other Toledo Catholic high schools, St. Mary's College, his local parish, and other Catholic institutions. His son Gerald said that nothing made his dad happier than giving to people who would benefit from a Catholic education.







The scholarship was founded in 2016 through the loving efforts of his close friend, Tony DiSalle '82, and his sister, Kim (Lyddy) DiSalle, as a way to make a lasting impact in the lives of students who desire a St. John's Jesuit education but cannot afford it.

#### THE KEVIN LYDDY MEMORIAL SCHOLARSHIP '81



In May 1981, Kevin Lyddy died in a motorcycle accident just days before he was to graduate from St. John's. While it's hard to believe that Kevin has been gone for 40 years, his short life served as an example for us all of how to live.

Kevin was fun, loving, protective, and outgoing. He excelled in athletics, so much so that many years after his death, St. John's awarded the most accomplished athlete of each graduating class "The Kevin Lyddy Award." While he was an intense competitor in sports, off the field or mat he was an approachable, humble, cheerful, fun-loving son, brother, and friend. Kevin knew that "his gifts" were not his own; they were from God and were to be shared with others. He had the humble heart of Christ and would do anything for somebody in need.

Kevin loved to help guide and teach younger people. Some of his best memories were coaching and counseling kids. In the summers while at St. John's, he coached and mentored kids at a local orphanage run by Toledo Catholic Charities and at a summer camp. His plan was to attend The Ohio State University for college and become a teacher and coach. While he couldn't live out that dream physically here on earth, his spirit and dream live with us today as he continues to help younger people. His family established a scholarship endowment fund at St. John's in his name. The Kevin Lyddy '81 Memorial Scholarship has helped a student based on need at St. John's Jesuit every year since it was established. In the spirit of Kevin, a true Man for Others, the scholarship criteria is simply need. Kevin remains there for these young men and continues to help them today through this scholarship.






### THE YOUNG ALUMNI COUNCIL CONTINUES TO GROW AND THRIVE




